

Photographic Makeup Award Beginners

This course will enable you to initiate your career as a makeup artist in beauty salons, doing bridal and photo-shoot, or continue to Level 3 (Level 4 MQF) Diploma. Build up your portfolio and makeup kit/tools. You will study facial anatomy, health, and safety best practice, skincare, the correct use of tools and products, the principles of lighting and shading in make-up, as well as color mixing and blending the application of bases, and beauty make-up for both day and evening and you will look at how makeup is influenced by a different light.



This qualification is suitable for learner's aged 16 and over.

Make-up application to include the understanding of face shapes, skin characteristics, fashion trends, cultural factors, effects of sunlight, planning make-up application – images, themes, colour, research, use of mood board.

This qualification also provides:

Opportunities for learners to develop a range of skills, techniques, personal qualities and attitudes essential for successful performance in employment as a photographic make-up artist

Students work through a comprehensive syllabus addressing the key make-up techniques required by professional artists working in these industries inspired and guided by true professionals.

Classes (Maximum 4 students) are taught through practical demonstrations and one-to-one attention on each student's work. Students work on each other, training mannequins or a model with a very practical and hands-on approach from day one.

An Award by iTEC-VTCT International qualification at Level 2 (Level 3 MQF & Europe Qualification Framework) will be issued.

The classes will be from:

This qualification is suitable for learners aged 16 and over and is designed to provide occupational competence at level 2. It also provides a sound platform into further training at level 2 and 3.

Content

This qualification is for learners who want to work within the make-up industry. The qualification consists of 1 mandatory unit with a total of 30 hours of Guided Learning (GL) to achieve the full qualification.

The main skills the learner will perform are:

- Make-up application to include the understanding of face shapes, skin characteristics, fashion trends, cultural factors, effects of sunlight, planning make-up application – images, themes, colour, research, use of mood board

The learner will also develop knowledge about related health and safety and client care and communication which is essential to work and be successful in the make-up industry.

This qualification also provides:

- The related knowledge and understanding required to perform photographic make-up listed above as well as understanding the structures that the learner will be working over, in particular recognition of skin types and skin conditions and reasons that may affect whether a client should or should not be treated
- Opportunities for learners to focus on the development of their wider skills in a make-up setting, such as communicating with clients, working with others and problem solving
- Opportunities for learners to develop a range of skills, techniques, personal qualities and attitudes essential for successful performance in employment as a photographic make-up artist

Opportunities for progression

Once learners have achieved the VTCT (ITEC) Level 2 Award in Photographic Make-up they may progress on to other VTCT (ITEC) or equivalent qualifications at level 2 or 3 for example:

Guided Learning Hours (GLH)

Guided Learning Hours is 'the activity of a learner in being taught or instructed by – or otherwise participating in education or training under the immediate guidance or supervision of – a lecturer, supervisor, tutor or other appropriate provider of education or training'. This includes 'the activity of being assessed if the assessment takes place under the immediate guidance or supervision of a lecturer, supervisor, tutor or other appropriate provider of education or training'.

Total Qualification Time (TQT)

Practical examination

All practical assessments must be conducted in a controlled environment defined by VTCT (ITEC). The practical examination will be conducted by an external examiner; however, the centre is responsible for ensuring the examination can operate seamlessly by organising the process as defined in the 'Instructions for Conducting Examinations' which can be found on the ITEC website. The marking criteria and marking scheme can be found under the documents tab within the qualification.

Portfolio of evidence

The assignment forms part of the internal assessment and should be assessed throughout the training by the lecturer using the appropriate forms.

The assessment form for the unit should be completed and placed with the relevant documentation for verification by the external examiner.

Quality assurance

A scheme of work must be approved by VTCT (ITEC) for all units prior to the commencement of the course.
